### **Privacy notice for registration and facilitation of OARVIL**

#### **Data protection**

In the course of registering to join OARVIL, you have provided information about yourself ('personal data'). We (the University of Oxford) are the 'data controller' for this information, which means we decide how to use it and are responsible for looking after it in accordance with the UK General Data Protection Regulation and associated data protection legislation.

#### **How we use your data**

We will use your data to register your interest in joining the OARVIL project, to contact you about future research and to approach you as a potential participant in future research studies. We would only contact you about research studies which we think you may be eligible for.

If you have consented to receiving the semi-annual newsletter from the OA Centre of Pathogenesis Versus Arthritis, your data will also be used to send this newsletter with news and updates on current studies.

We are processing your data for these purposes only because you have given us your consent to do so, by submitting the registration form. You can withdraw your consent at any time by contacting us at [oacentre@kennedy.ox.ac.uk](mailto:oacentre@kennedy.ox.ac.uk). In this event, we will stop the processing as soon as we can. However, this will not affect the lawfulness of any processing carried out before your withdrawal of consent.

We will only use your data for the purposes for which we collected it.

We are collecting the minimum personal data required to meet our purposes outlined above.

#### **Who has access to your data?**

Access to your data will be provided to those who need to view it as part of their work in carrying out the purposes described above.

We may share your data with companies who provide services to us. These companies are required to take appropriate security measures to protect your data in line with our policies. We do not allow them to use your data for their own purposes. We permit them to process your data only for specified purposes and in accordance with our instructions.

#### **Retaining your data**

We will only retain your data for as long as the OARVIL project is running and for as long you provide us consent.

#### **Security**

Your data will be held securely in accordance with the University's policies and procedures. Further information is available on the University's Information Security website.
